Terms and Conditions of Membership

Subscriptions

- Acceptance of your application shall be communicated by way of an invoice on behalf of the Association in respect of the undermentioned annual subscription fee payable to the Association, and shall be renewed annually absent written notification of resignation from you/revocation to you, save that:
 - Membership for all Old Girls/Boys is free for the first year after school (first year Old Girls/Boys).
 - Membership for teachers is free.
- The annual subscription fee (decided at a Council Meeting by the Council), currently R265.00, is due in full by 1 October of each year. Failure to pay will result in your membership being revoked.
- Payment is to be made to **Old Parktonian Sports Club, Standard Bank cheque account number 022286349, branch 006605 with reference: OPA, your initial and surname**. Confirmation of payment must be sent to oldparks@mweb.co.za, where after your payment will be passed on to the Association.

Behaviour and dress

- No drunken and disorderly behaviour will be tolerated – this includes any form of aggressive behaviour.
- Language must be kept at a level befitting a Parktonian.
- Memorabilia, furniture, fixtures and fittings must be respected and looked after at all times. Damage to abovementioned property will be for the account of those parties responsible.

Disciplinary Action

- The Committee reserves the right to revoke membership should members fail to pay their subscriptions or be found guilty of contravening any other terms and conditions of membership or provision in the Constitutions of the Association and the Sports Club. Members may be requested to appear at a disciplinary hearing should the Committee find just cause. The Committee's disciplinary decision is final.
